Collecting and enforcing cigarette taxes for Northern Virginia – Counties of Fairfax, Fauquier, Loudoun, Prince William, Spotsylvania, Stafford, Cities of Alexandria, Fairfax, Falls Church, Fredericksburg, Manassas, Manassas Park, and the towns of Clifton, Dumfries, Haymarket, Herndon, Hillsboro, Leesburg, Lovettsville, Middleburg, Purcellville, Remington, Round Hill, Vienna, and Warrenton.

IMPORTANT NOTICE

The County of Stafford will be increasing the local cigarette tax rate from \$0.30 to \$0.40 effective July 1, 2024.

Code of Virginia §58.1-3830.D requires that you complete a report listing the count of your unsold inventory as of the end of the day Sunday, June 30, 2024.

The form on the other side of this letter must be submitted to our office by **December 31, 2024**, and payment must be submitted by **June 30, 2025**. If the report is not received by December 31, 2024, the NVCTB will process a statutory assessment of the tax required and issue a notice of such assessment with a demand for immediate payment of the tax including penalties and interest.
